PrimeXBT Terms and Conditions - Refer a Friend Bonus Program

Introduction

The present Refer a Friend Bonus Program Terms and Conditions (hereinafter the "**Referral Program Terms**"), shall apply to all clients (hereinafter the "**Client(s)**", "**you**", "**your**") of PrimeXBT Trading Services Ltd, a company incorporated and existing under the laws of Saint Lucia, with Registration No. 2024-00343, having its registered office address at PKF Corporate Services Ltd., 1st Floor, Meridian Place, Choc Estate, Castries, Saint Lucia (hereinafter "**PrimeXBT**", the "**Company**", "**we**", "**us**", "**our**", as appropriate).

PrimeXBT provides its Clients with an opportunity to earn a referral reward of 300 USDT as a trading credit (hereinafter the "**Reward**") for referring friends (hereinafter the "**Referees**") to our trading platform (hereinafter the "**Referral Program**").

(hereinafter the "Promotion Period").

To be eligible to participate in the Referral Program, you must proceed with the following during the Promotion Period:

- 1. Be an existing and approved PrimeXBT Client in accordance with the Company's Terms and Conditions (Agreement) that can be found in the Company's official website (<u>https://primexbt.com/</u>);
- 2. Be a natural person with full legal capacity and over eighteen (18) years of age;
- 3. Have access to the unique referral link (hereinafter the "**Referral Link**") that can be obtained in the referral section inside the PrimeXBT platform (hereinafter the "**Platform**").

In case the above conditions are satisfied, the Client is eligible to participate in the Referral Program and start referring people to the Company's Platform (hereinafter the "**Referrer**").

Reward Conditions
